One copy of your Business Plan and/or Executive Summary which includes at a minimum, a clear and concise description of the new or expansion project, the number of full-time or FTE jobs to be created, the size of the investment to be made for land, buildings and/or leasehold improvements, the product to be manufactured or produced, identified market analysis, financial forecasts for three years and schedule for construction start and expected completion dates. *DISCLAIMER: This information will all be kept confidential, and financial information can be directly delivered to the City of Saskatoon; contact available upon request.*
- B. A copy of ISC Profile Report indicating entity type, status and incorporation date.
- C. A copy of the blue prints for the new building, expansion, or renovations.
- D. Recent financial statements or a letter from a bank indicating that the applicant has the financial resources to complete the project in question.
- E. A current payroll list (including names, positions and full-time equivalents).
- F. If the applicant is not the legal owner of the property for the planned build or expansion, provide a copy of the lease agreement upon application.

Please Note: The Saskatoon Regional Economic Development Authority (SREDA) Inc. must receive your incentive application before you apply for a building permit from the City of Saskatoon. An application for abatement shall remain open for a period of one year from initial date of receipt of application and any applications that are incomplete after this time will be deemed abandoned and closed.
