



## 2021 VOYAGE

SREDA's Agri-food Technology Program in partnership with Global Agri-food Advancement Partnership (GAAP)

### Official Rules

**Eligibility:** The 2021 SREDA AGRICULTURE TECHNOLOGY PROGRAM ("VOYAGE") is open to Canadian residents and international applicants who are over the age of majority in their province/territory of residence at the time of entry.

Saskatoon Regional Economic Development Authority ("SREDA") employees, representatives and agents of the companies and organizations participating in the VOYAGE Selection Committee ("Selection Committee") as well as the immediate family members (spouse, children, parents and siblings) and those living in the same household of such employees, representatives and agents are not eligible to enter. Void where prohibited by law.

**How to Enter:** Company representative should fill in the VOYAGE Application Form ("Application") available at <https://sreda.com/what-we-do/voyage/> and submit to [jbaczuk@sreda.com](mailto:jbaczuk@sreda.com). Applications can be submitted from 9:00 a.m. June 22, 2021 until 11:59 p.m. (CST) on August 12, 2021 ("Program Application Period"). Limit one (1) entry per company.

SREDA is not responsible for any lost, late, illegible, incomplete, falsified, destroyed, or failed applications, or failures of any kind, which may limit an entrant's ability to participate in this Program. All applications become the property of SREDA and will not be acknowledged or returned. Any and all lost, late, illegible, incomplete, falsified, destroyed, or failed applications will be disqualified.

### **The Prize:**

- Up to CAD 4,000 to be used for travel and accommodations while enrolled in the GAAP incubator
- Opportunity to participate in a three month GAAP incubator (\$5,000) at a discounted rate of 50% (\$2,500)
- Opportunity to showcase their technology to the Saskatchewan agri-food and agriculture industries
- Networking with industry leaders and exploration of business opportunities in the Saskatoon Region

**Selection Process:** The VOYAGE Selection Committee will be responsible for evaluating and selecting winning applications. The Committee retains the right to select one or more applications to receive the Prize.

The companies whose application form complies with these Official Rules will be eligible to win the Prize. The chance of being selected will depend on the number of eligible entries received during the Program Application Period.



**Confirmation:** Selected companies will be notified by SREDA no later than **September 15, 2021**. SREDA will make reasonable efforts to contact the potential winner by telephone (if telephone number provided) and/or email within ten (10) business days following the selection date. If the potential winner cannot be contacted within the time specified above, is not otherwise an eligible applicant, or does not otherwise comply with the Official Rules, this company will not win the Prize. In this event, the Prize will be awarded to an alternate applicant, selected from among the remaining eligible entries and who otherwise complies with these Official Rules.

By participating in the Program entrants agree to be bound by these Official Rules and the decision of SREDA and the Selection Committee, which is final and binding in all respects. The Prize must be accepted as awarded. No substitution or transfer of the Prize is permitted, except that SREDA reserves the right, in its sole discretion, to substitute a Prize of equal or greater value. Return of any Prize notification as non-deliverable or failure to comply with these Official Rules will result in disqualification and an alternate entrant may be selected in accordance with the Official Rules.

**Consent and Release:** By participating, entrants agree: (1) that SREDA does not endorse or guarantee the legitimacy of winning technologies; (2) that SREDA may (unless prohibited by law) use winner's name, city of residence, photograph, image and/or likeness for advertising and other promotional purposes, without further review or compensation, in any media; and (2) to hold SREDA, its affiliates, distributors, dealers, employees and agents, and their respective directors, officers, employees, representatives, agents and assigns harmless against any and all claims, loss, liability, injury or damage to entrant or any other person or entity due in whole or in part, directly or indirectly, by reason of their acceptance, possession or use of the Prize or their participation in this Program.

**Use of Personal Information:** Personal information gathered by SREDA will be used for the purposes of administering the Program, contacting potential winners and as otherwise permitted or required by law.

**Governing Law:** The Program is subject to all federal, provincial and municipal laws. The Program and the Official Rules will be exclusively governed and construed in accordance with the laws of the province of Saskatchewan unless otherwise prohibited by law.
